**\*DCNM Youth Rider Dressage Rail Classes (DRC)** are multi-entry Classes based on youth age divisions. Each Class of entered riders will show in the arena at the same time. There is no test pattern required. **Leadline Class Age Groups 3-4, 5-6** are judged on 1) Proper seat, leg and hand position, and 2) Poise/Confidence. Adult controls the pony/horse. **Class Age Groups 7-9, 10-12, 13-15, 16-18** are judged on the level of skill based on USDF Intro; USDF Training; and USDF 1<sup>st</sup> levels. The Judge will call the gait of Walk, Trot, Canter (not Div I), Halt or Change Rein, as required to observe and score the rider and horse for: 1) Position and aids of rider; 2) Skill and obedience of horse; and 3) Overall harmony of partnership. Rider controls the pony/horse. All DRC Class Scoring is 0 (Not Demonstrated) through 10. Please indicate these Classes on your entry form as "DRC/Age Group/Class Div"

## SHOW FACILITIES/GROUNDS

### Day of Show:

- One 20m x 60m Competition Dressage Court at Florisena Arena I (for Fri Freestyle & Sat 20x60 tests)
- One 20m x 40m Competition Dressage Court at Piñon Arena I (for Sat 20mx40m tests and DRC Classes)
- One 20m x 60m Warm Up Ring at Florisena Arena II (no lunging)
- One 20m x 40m Warm Up Ring at Piñon Arena II (no lunging)
- One 62' Round Pen (For lunging only, one horse at a time. No free lunging)
- Piñon Show/Clinic Barn – 10 Stalls, 6 Pens (each require 2 shavings bags minimum)
- HCF Hunt Box Show Office with an Outdoor Commercial Portable Toilet and Handwashing Station

### Footing (Footing may be watered during competition breaks):

- 145'x220' Florisena Arena I and II – Groomed Sandy Loam over compacted, prepared clay subsurface.
- 70'x160' Piñon Arena I – Groomed Sand and Rubber Crumbles over compacted, prepared crusher fine subsurface.
- 65'x130' Piñon Arena II – Groomed Amended Sandy Loam
- 62' Round Pen – Groomed Sandy Loam over compacted, prepared clay subsurface.

## FACILITIES/GROUNDS DAMAGE POLICY

Any damage to HCF Show Facilities or Grounds is the responsibility of the damaging party (if a horse, its owner). Repairs and replacement costs will be charged to damaging party.

## PARTICIPANT ENTRY REQUIREMENTS

Each Rider, Parent/Guardian, Owner, Trainer/Coach, or Groom of a Rider (all of which will be known individually as a "Participant") must read and sign a Release of Liability Form (see Prize List Page 6) and submit it to the Show Secretary.

## HORSE ENTRY REQUIREMENTS (Competing and Non-Competing Horses)

- Each horse on the show grounds must be entered individually and have a bridle number.
- Each Horse must have its own ENTRY FORM (please do not list more than one horse per entry form).
- Each Horse Entry must send a valid Coggins Test Report that is one (1) year old or less to the Show Secretary before the Show Closing Date.

NO HORSE MAY ENTER the Show Grounds without having a Coggins Test Report on file with the Show Office.

## STABLING – Piñon Show/Clinic Barn

Ten 10x10 Stalls with rubber mats of over dirt and Six 12x12 Stall Pens are available until sold out. You must submit an Entry Form to reserve a stall. **Each stall requires two bags of shavings.** You may bring your own shavings or purchase two or more bags on your Entry Form at \$10 per bag. Please bring your own water/feed buckets and stall cleaning implements.

## TRAILER-IN – Day of Show

Entries may trailer-in on Day of Show. Trailer-In Entries may only tie and tack up/down at their trailer. Please do not use stalls/pens, tack or wash stalls in Pinon Show/Clinic Barn.

## TRAILER PARKING

There will be trailer parking at the side of the driveways and in the parking areas near Pinon Show/Clinic Barn and Florisena Arena. Please do not park in a way that obstructs safe flow of traffic or safe handling of horses.

## REFUNDS

There is no refund of any fees paid, if an Entry is scratched for any reason, at any time, or fails to check in Day of Show. Refund only if DCNM cancels show for any reason before closing date. Refunds will be made to Entry's original source of payment.

## WEATHER DELAYS/CANCELLATIONS

DCNM reserves the right to temporarily halt all riding and delay a class due to unsafe weather conditions. DCNM reserves the right to cancel a show entirely if weather poses a safety issue that does not allow safe riding for more than 3 hours during official Show Office hours of 7am to end of last scheduled test ride.

## PET POLICY

Dogs, cats, birds, reptiles (or any species of animal which is a pet) are NOT permitted at any time on the HCF property. This includes any Pet which might be secured in a kennel, stall, vehicle or trailer. Service canines must register with the Show Secretary before the Entry Closing Date and be in control of the owner at all times.

## **RIDER ATTIRE AND HORSE TURNOUT**

There is no required “show clothing” attire for the Schooling Show, however, it is encouraged. Braiding is not required, however, it is also encouraged. All riders must wear boots with heel, a helmet and the riding apparel appropriate for schooling their discipline of dressage. Horses should be clean and free of debris or mud in their coat, tail and mane.

## **REQUIRED RIDER SAFETY EQUIPMENT**

A helmet securely and properly fastened to a rider’s head is required at all times while mounted on a horse. Protective riding vests are optional and at the rider’s discretion. No bicycle or ski/skate helmets allowed.

## **SPORTSMAN-LIKE CONDUCT**

DCNM Sportsman-Like Conduct Statement: Recognized standards of acceptable good sportsmanship behavior are required at all times of all individuals on the show grounds. Violations include, but not limited to acts of violence, abuse, bullying, disregard for any rules/policies. Aggressive verbal or physical attacks on officials, show staff, other persons or horses may result in the immediate dismissal of the party(ies) committing the violation.

In Consideration, therefore, for the privilege of using/entering Premises, or at any event Participant attends that is hosted by DCNM, and/or Farm Owner, Participant's horse attends, or competes within the event to which this Release applies, its agents or assigns, the Undersigned does hereby agree *NOT TO SUE* and to hold harmless and indemnify the DCNM, Farm Owner, its agents, officers, directors, volunteers, employees, contract labor or family, assigns and successors, heirs, and further releases them from any and all liability or responsibility for accident, damage, injury, illness, or death to the Undersigned or to any horse owned by the undersigned or to any family member or guest accompanying the Undersigned onto the premises or to the event. Such agreement Not To Sue and hold harmless shall cover all events and material issues associated with riding and/or being physically around horses including but not limited to: handling horses in stalls and other areas; loading/unloading horses from trailers; standing in proximity to horses which may cause Participant to be injured or killed; grooming and shoeing horses; saddling, bridling and otherwise preparing horses for riding; administering shots, medications or other medical care; the use of equipment on horses or for horses (and any equipment failure thereof ); human error; and any and all other matters of whatever nature that may arise from the riding and/or being around horses on the Premises, or for being on the Premises for any and all other activities which does not include horses, whether such risk is known or unknown at the time of harm, loss or injury and/or death. Participant assumes all liability and responsibility for his/her personal property. **This agreement NOT TO SUE or effect any other claim of liability against the aforementioned DCNM and Farm Owner shall apply to any and all accidents, incidents or events that might be believed to have caused harm, damage, death or loss, whether risk of such accident, incident or event was known or unknown by any individual at the time of the occurrence, or whether a horse(s) was involved or not.**

Further, Participant states that he/she has read the New Mexico Equine Activity Statute in its entirety and understands its contents in its most up-to-date, legally enforceable version. Participant understands that there are intrinsic dangers of equine activities as stated in the New Mexico Equine Activity Statute Sec. 42-13-2-4, and other dangers that exceed the Statute. Any excess liability is fully covered under this Release.

This Release shall remain in full force and effect until expressly revoked in writing, and upon revocation, the Undersigned acknowledges that the Participant will be immediately dismissed from the Premises or alternative venue associated with DCNM and/or Farm Owner, until another Release is signed.

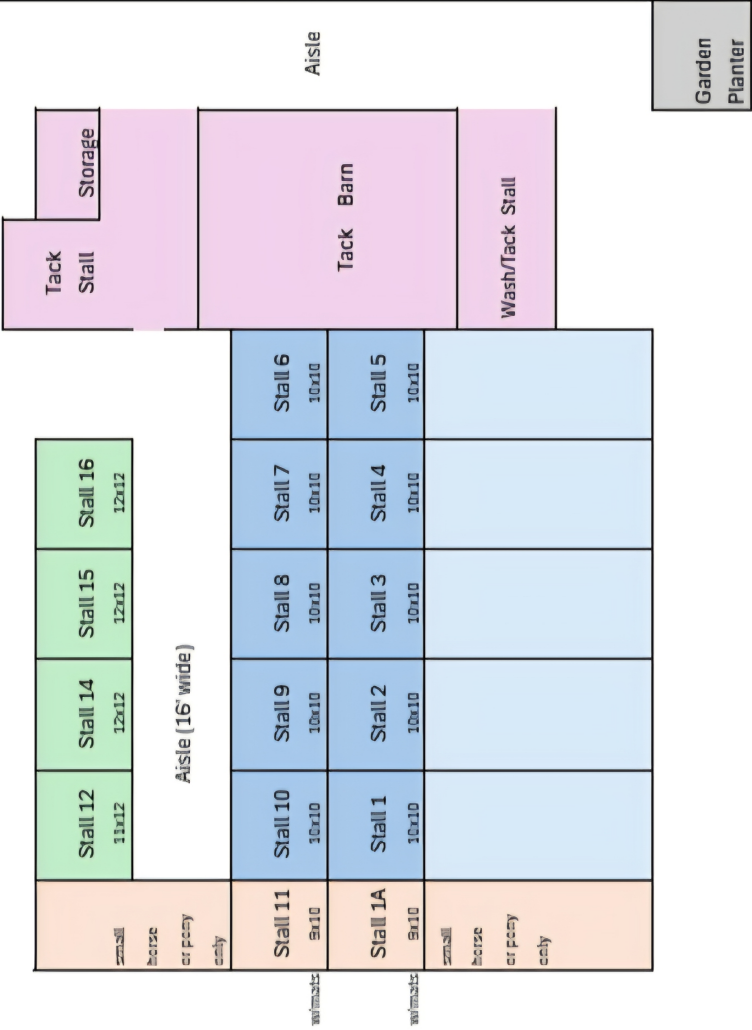
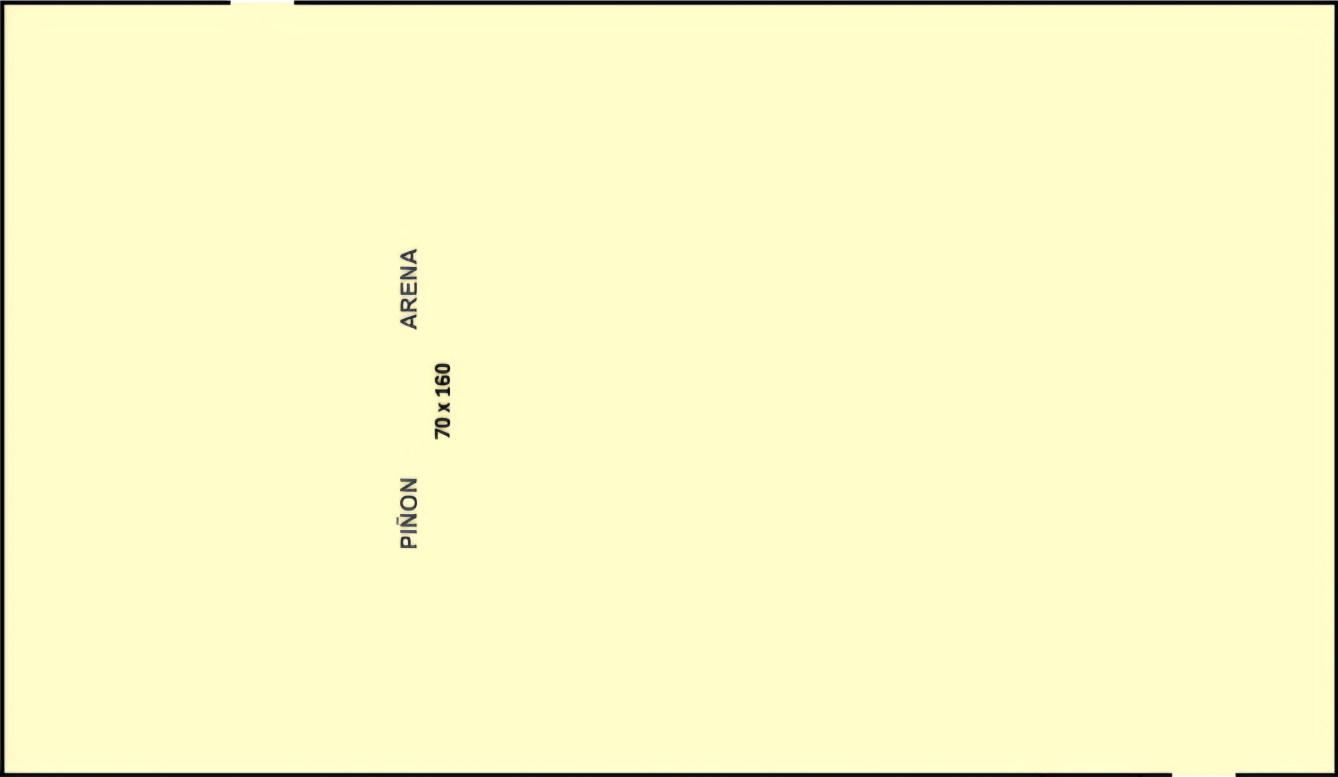
